## WILL OF NARGARET PHILLIPS

Last Will and Testament.

I, Margaret Phillips of District of Cameron, County of Marshall and State of West Virginia, being of sound mind and memory, do hereby make, publish and declare this to be my last Will and Testament, in manner and form following, hereby revoking any will or wills heretofere made by me.

First. I direct that all my just debts and funeral expenses be fully paid and satisfied, as seen as conveniently may be, after my decease.

Second. I devise and bequeath to my foster daughter Sarah Eckels all of my real estate of which I die seized in fee, as well as all of my personal property, for and during the term of her natural life.
