Killed in Action September 24, 1918; buried at Meuse-Argonne American Cemetery, France

Thomas Miller McMillan, born in Wheeling on April 13, 1894, was the son of William McMillan and Margaret Roberts, residents of Eoff Street, Wheeling, in 1900, and Chapline Street, Wheeling, in 1910. Mr. McMillan a bookkeeper, was employed at Haskins Hospital in 1910. In addition to Thomas, the McMillan children were Etta, Edyth/Edith, Fred, Edgar, and Walter W.
